II. APPROVAL OF THE MINUTES

PDD Vibration Limit - Per the PDD #23 and #24 Ordinances, ground vibration resulting from P&D blasting shall not exceed 0.30 inches per second on at least 85% of its blasts within any single calendar year. The Operator shall not exceed the ground vibration limitation imposed by the Wisconsin Department of Industry, Labor and Human Relations in Figure 7.64 of ch. ILHR 7, Wis. Adm. Code (new reference now Wis. Adm. Code, Safety and Professional Services Chapter 307), or 0.65 inches per second, whichever is more restrictive, on any blast.

PDD Airblast Limit - Per the PDD #23 and #24 Ordinances, airblast resulting from P&D blasting shall not exceed 123 dB on at least 85% of its blasts within any single calendar year. The Operator shall not exceed the airblast limitation imposed by the Wisconsin Department of Industry, Labor and Human Relations in ch.ILHR 7, Wis. Adm. Code on any blast (new reference now Wis. Adm. Code, Safety and Professional Services [SPS] Chapter 307).
