**MINUTES**

I. The June 29, 2020 Police & Fire Commission Meeting was called to order at 4:15 p.m. by Commission President Donohoo in the Franklin City Hall Hearing Room. Members present were Commissioners Donohoo, Lenz, and Schnagl. Commissioner Mineo was excused. Also in attendance were Fire Chief Remington and Human Resources Coordinator Zahn.

II. The Promotion of Fire Department Firefighter/Paramedic Edward Schmidt to a City of Franklin Fire Department Lieutenant.

Motion by Commissioner Schnagl and seconded by Commissioner Lenz that Edward Schmidt is hereby appointed to the position of City of Franklin Fire Lieutenant effective 7/7/2020, that said appointment is subject to a 1 year introductory period commencing on the effective date of his appointment, that the 1 year introductory period will expire at the end of 1 year unless extended by the Commission, and the Fire Chief shall provide the Commission reports of his progress when requested by the Commission.
