MINUTES

I. The April 8, 2021 Police & Fire Commission Meeting was called to order at 12:00 p.m. by Commission President Donohoo in the Franklin City Hall Hearing Room. Members present were Commissioners Donohoo, Mineo, Lenz, Schnagl (arrived at 12:02), and Martins. Also in attendance was Police Chief Oliva.

II. Approval of the Minutes of the February 18, 2021 and March 18, 2021 meetings.

Motion by Commissioner Mineo and seconded by Commissioner Martins to approve the minutes as written. Motion Carried: Ayes – All.

III. The Promotion of Patrol Officer Branndyn A. Mullikin to a Position of City of Franklin Police Department Sergeant.

Motion by (couldn't decipher voice from recording) and seconded by Commissioner Lenz that Branndyn A. Mullikin is hereby appointed to the position of City of Franklin Police Department Police Sergeant effective 4/9/2021, that said appointment is subject to a 1 year introductory period commencing on the effective date of his appointment, that the 1 year introductory period will expire at the end of 1 year unless extended by the Commission, and that the Police Chief shall provide the Commission reports of his progress when requested by the Commission. Motion Carried: Ayes – All.

IV. The Creation of an Amended Eligibility List for the January 2021 Police Patrol Hiring Process – Existing Officers.

Motion by Commissioner Lenz and seconded by Commissioner Mineo that the name of John Stancel be added to the eligibility list from the January 2021 Hiring Process. Motion Carried: Ayes – All.

V. Hiring of Police Patrol Officer. The Hiring of John F. Stancel as a Police Department Police Patrol Officer from the 2021 POLICE PATROL HIRING PROCESS – EXISTING OFFICERS. The Police and Fire Commission may enter into closed session pursuant to sec.19.85(1)c to consider the employment of John F. Stancel as a Police Patrol Officer. The Commission will then reconvene into open session at the same place thereafter to act on such matters as it deems appropriate and to continue the meeting agenda items.

The Commission did not go into closed session. Motion by Commissioner Lenz and seconded by Commissioner Martins that John F. Stancel is hereby appointed to the position of City of Franklin Police Officer effective 5/3/2021, subject to the condition that the Commission President agrees that he meets all requirements, that said appointment is subject to a 1 year introductory period commencing on the effective date of his appointment, that the 1 year introductory period will expire at the end of 1 year unless extended by the Commission, and that the Police Chief shall provide the Commission reports of his progress when requested by the Commission. Motion Carried: Ayes – All.
