Operating Motor Vehicle While Intoxicated – 2nd Offense S 20th St/W College Ave

On Monday, 02/12/24, at 0217 hours, a subject out of Oak Creek was taken into custody for Operating A Motor Vehicle While Intoxicated-2nd Offense. He later provided an evidentiary breath sample which indicated that he had a Prohibited Alcohol Concentration of 0.21. He was booked, cited, and released to a sober party after posting bail. Charges were referred to the District Attorney's office for review.
