## VI. New Business

#### A. Assessment

 Milw. Co. (SurvNet) and FHD Communicable Disease Reports The Board reviewed the December Milwaukee County SurvNet report as well as the Franklin Health Department communicable disease report. Milwaukee County overall had a decrease in communicable diseases for the year. The reported cases in Franklin, however, are 11% higher in 2017 compared to 2016.

Respiratory Virus
(Influenza)
Disease Report

The Board reviewed Influenza report which indicated the 2017/18 has an earlier start for the flu season for the last three (3) years.

3. City of Franklin Immunization Rate Assessments:

The immunization audit report of the eight (8) daycares in Franklin compiled by Kim Kringel was reviewed.

a. Annual Franklin Day Care Audit Report

Data samples of Franklin children between the ages of 2 and 3 years of age are meeting the goal in 2020 Healthiest People for childhood immunization.

b. Assessment of Childhood Rates, 24-35 months

The adolescent rates of immunization were also reviewed. They are better than the statewide average but need improvement with for HPV completion and the seasonal influenza vaccines.

A. Public Health Nurse Residency Program By Julianna Manske RN, MSN Julianna Manske discussed the creation of the curriculum which is based on literature and a public health model called Foundational Public Health Services – there are five (5) pieces to that model. The program was designed to help the new public health nurses elevate their skills, recognize the tools and resources needed to be successful. The program is also open to other health care professionals that are new to public health or someone who wants to brush up on new resources. Based on participants' evaluations the program was very successful. There is potential for the program to obtain grant funding and then bring it outside of our region.
