NOTICE OF PUBLIC HEARING**

NOTICE IS HEREBY GIVEN THAT THE PLAN COMMISSION OF THE CITY OF FRANKLIN will conduct a public hearing on Thursday, April 5, 2012, at 7:00 p.m., or as soon thereafter as the matter may be heard, in the Common Council Chambers at the Franklin City Hall, 9229 West Loomis Road, Franklin, Wisconsin 53132, to hear public comment regarding an application by LaQueesha Rochelle Blockton, d/b/a Academy of Integrity, for a Special Use under Standard Industrial Classification Title No. 8299 "Schools & Educational Services, Not Elsewhere Classified" to allow for an educational facility use upon property zoned I-1 Institutional District, located at 3900 West Ryan Road, more particularly described as follows:

Part of the SW 1/4 of Section 24, T5N, R21E, in the County of Milwaukee, Wisconsin, described as follows: Commencing at the southwest corner of said SW 1/4 Section: Thence North 88 degrees 21 feet 19 inches East along the South line of said 1/4 Section, 1175.81 feet; thence North 1 degree 38 feet 41 inches West, 130.00 feet to the place of beginning of the lands to be described; thence continuing North 1 degrees 38 feet 41 inches West 584.83 feet; thence South 87 degrees 00 feet 54 inches East, 408.82 feet; thence South 8 degrees 07 feet 59 inches West, 150.00 feet; thence southeasterly 298.09 feet along the arc of a circle whose center is to the West, whose radius is 878.51 feet and whose chord bears South 1 degree 35 feet 15.5 inches East, 296.66 feet; thence South 11 degrees 18 feet 30 inches East, 108.89 feet; thence South 88 degrees 21 feet 19 inches West, 400.00 feet to the place of beginning, containing 5.0004 acres, more or less; Tax Key No. 880-9998-003.

This public hearing is being held pursuant to the requirements and standards of §§15-3.0701 General Standards for Special Uses, 15-3.0703 Detailed Standards for Special Uses in Nonresidential Districts and 15-9.0103 Applications for Special Use Permit, of the City of Franklin Unified Development Ordinance. A copy of the proposed Special Use resolution in draft form is available and open for inspection by the public in the office of the City Clerk at Franklin City Hall, 9229 West Loomis Road, Franklin, Wisconsin 53132, during normal business hours. The public is invited to attend the public hearing and to provide input. The proposed draft form resolution is subject to revisions following public hearing and the further consideration by the Plan Commission and the City of Franklin Common Council.
