- 43. Failure to obtain permit before commencing work
  - a. First offense Triple fee (3X)
  - b. Second offense or repeat offender Quadruple fee (4X)
- 44. Trip charge for offsite duplication of plans, etc. \$35.00
- 45. Technology Fee
  - a. Permit fee is less than \$100 \$2.00 per permit
  - b. Permit fee is greater than or equal \$100 \$5.00 per permit

**NOTE:** Projects for the City of Franklin, that require electrical permits are exempt from permit fees.

**NOTE:** If construction is not commenced prior to expiration of the permit, that portion of the permit fee, excluding plan exam fees that exceeds the minimum fee will be refunded upon written request.

**NOTE:** Before any work is commenced or recommenced after a permit has expired, a new permit shall be re-issued at one-half (1/2) the regular fee. Or at the Re-inspection rate for each remaining inspection. The method used shall be determined by, and at the sole discretion of, the Building Inspector.

SECTION 2.0: All ordinances or parts of ordinances in contravention to this ordinance are hereby repealed.

SECTION 3.0: This ordinance shall take effect upon its passage and publication as required by law.

SECTION 4.0 The terms and provisions of this ordinance are severable. Should any term or provision of this ordinance be found to be invalid by a court of competent jurisdiction, the remaining terms and provisions shall remain in full force and effect.
