
Weekly Roundup

04/08/2024

Possession of Controlled Substance 6901 S 76th St – Hampton Inn

On Monday, 04/08/24, at approximately 0101 hours, a subject out of Milwaukee was taken into custody for Possession of Drug Paraphernalia. This occurred during a K9 lot check of the Hampton Inn. She was cited on scene and released.

Operating Motor Vehicle While Intoxicated – 1st Offense, Warrant Arrest S 27th St/W Riverwood Blvd

On Monday, 04/08/24, at 0155 hours, a subject out of Milwaukee was taken into custody for Operating a Motor Vehicle While Intoxicated-1st Offense and a warrant with the Milwaukee County Sheriff's Office for Criminal Damage to Property and Disorderly Conduct – Domestic Violence. He later provided an evidentiary breath sample which indicated that he had a Prohibited Alcohol Concentration of 0.12. He was booked, cited, and turned over to MCSO personnel.

On Monday, 04/08/24, FRPD responded to a 2-vehicle crash in the HWY 100 construction zone. No injuries were reported.

Traffic Crash 6400 Blk S Lovers Lane Rd

On Monday, 04/08/24, during the first crash investigation, a two-vehicle crash occurred in the northbound lanes. This was due to inattentive driving, as the striking vehicle was observing the first crash.

Traffic Crash - Hit and Run 6400 Blk S Lovers Lane Rd

On Monday, 04/08/24, during the first two crashes in the construction zone, traffic came to a standstill. A vehicle almost struck an FRPD squad while an Officer had a lane shut down for the tow truck. The vehicle veered into another lane where it was side swiped by a truck. The truck fled the scene. The striking vehicle provided a plate and the vehicle owner was found at his apartment on W Cortez Circle where he was taken into custody for Hit and Run. He was booked, cited, and released.

Operating Motor Vehicle While Intoxicated – 1st Offense 7100 Blk S 76th St

On Monday, 04/08/24, at 2253 hours, Officers responded to a traffic crash where a vehicle flipped over. This occurred after dispatch received several calls for a reckless driver traveling south on S 76th Street. The driver was taken into custody for Operating a Motor Vehicle While Intoxicated - 1st Offense. He later provided an evidentiary blood sample, the results of which are not yet known. He was booked, cited, and turned over to a sober party.

On Tuesday, 04/09/24, OCPD requested a K9 walk around on a traffic stop. The driver was arrested for THC and paraphernalia located in the vehicle following the K9 alert.
