  - ii. Landfill Audit Report: Mostly everything has been fine/boring in the winter. Some small odors, gas odors from across street, working on south side helps with odor. One tracking complaint for both sites, which both sites responded very well.
  - iii. Well Sampling Contract: will discuss and approve at next meeting.

- b. WASTE MANAGEMENT REPORT, Waste Management Representative Brad Vanderkin presented.
  - i. Correspondence: working with DNR on Cell construction and wetland determination for expansion.
  - ii. 2024 Construction Updates:
    - Not too much new construction in 2024. No cap and no new cell this year.
    - New cell in 2025.
    - Corporate goal to reduce emissions by 42% by 2030. Planning to put in horizontals to get gas out of freshly placed trashed and putting in vertical wells

at final grade to extract as much gas as possible to get to engine and turbine plants.

# iii. Site Operations Updates:

- Filling continues in Cell 3A.
- Filling in the new cell, fluff-lift To reduce emissions by 2030.
- Getting dirt projects, traffic heavy lately.
- WE Energies has been out recently due to power outages.
- Installation of two horizontal wells recently. But otherwise normal operations.
- Weather has been a challenge lately with early Spring. Muddy track-out road conditions, but trying to keep that under control. Focusing on gas emissions and extractions.
- Residential yard driveway is pretty good now, but the fence needs repair. License scanner is working well, helps to deter out-of-towners and contractors.

Bill Theys moved to approve Waste Management report as presented by Brad Vanderkin. Seconded by Melvin Hebron. All voted aye; motion carried.
