- I. The Franklin Economic Development Commission (EDC) meeting was called to order at 4:02 p.m. by Chairman Bobowski.
- II. The floor was opened for Citizen Comment at 4:03 p.m. No citizens were present, and Citizen Comment closed at 4:04 p.m.
- III. Approve Minutes from the August 16, 2024 meeting Motion by Wesener, second by Barber, to approve. Motion carried.
- IV. 2024 Business Appreciation Celebration November 18, 5pm, Polish Center
 - a. Promotion/Invitation assistance Assistance with program and invitation generation and distribution and news releases is needed. \$800 is quoted by MCPR. Motion by Barber, second by Wesener, to approve. Motion carried.
 - b. Printed Program Format A decision is needed to decide if the program should be a 4-fold or 2-fold. Motion by Wesener, second by Barber, to have a 2-fold program. Motion carried.
- V. Biennial Report Proposal Erik Brooks of Brooks Communications reviewed his proposal to produce the Report. He learned a lot about Franklin by producing its Business Development Guide (BDG) and a Tourism Market Report. The Biennial Report will be 6 to 12 pages long, have the same look as the BDG, use data and photos thereof, and highlight accomplishments and programs by the EDC. Price will run from \$6,000 to \$7,500. Motion by Barber, second by Wesener, to approve, cost not to exceed \$7,500. Motion carried.
