## **08/12/2024**

### **Possession of Controlled Substance 7410 W Rawson Ave - Conservancy for Healing**

On Monday, 08/12/24, at 0048 hours, a subject out of Milwaukee was taken into custody for Possession of Marijuana. This occurred pursuant to a trespassing investigation at the Conservancy. He was booked, cited, and released.
