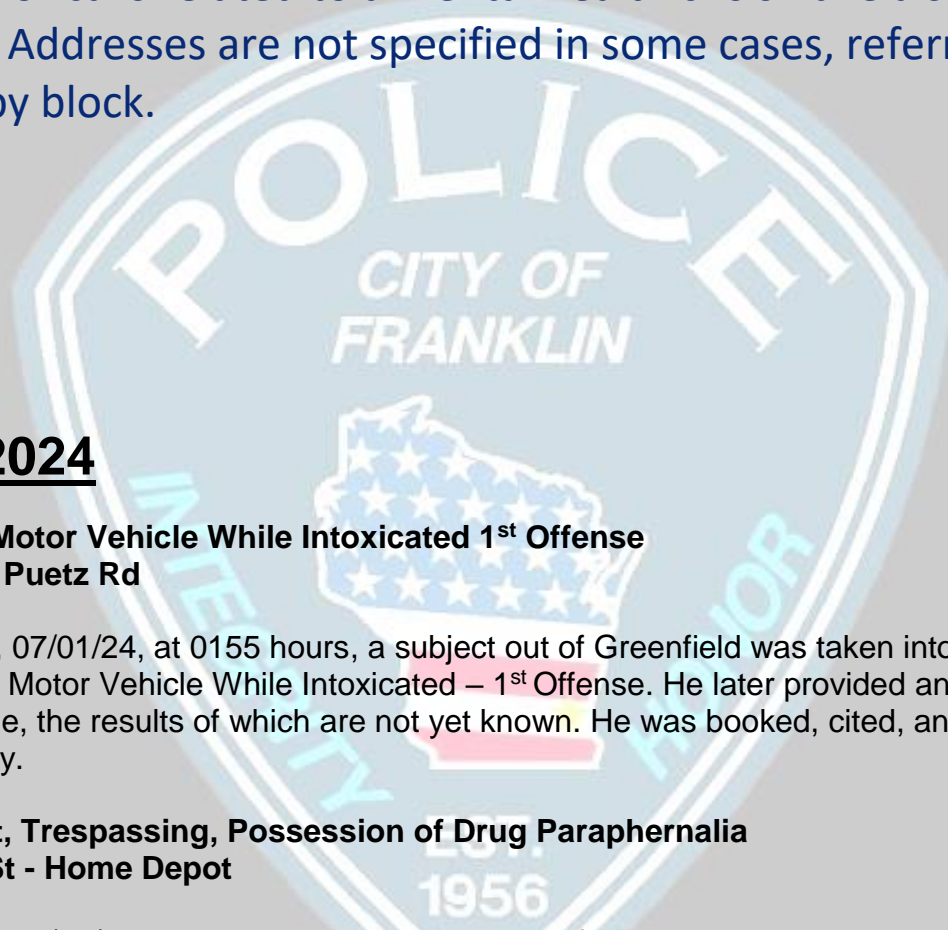

## 07/01/2024

### **Operating Motor Vehicle While Intoxicated 1<sup>st</sup> Offense S 27<sup>th</sup> St/W Puetz Rd**

On Monday, 07/01/24, at 0155 hours, a subject out of Greenfield was taken into custody for Operating A Motor Vehicle While Intoxicated – 1<sup>st</sup> Offense. He later provided an evidentiary blood sample, the results of which are not yet known. He was booked, cited, and released to a sober party.

**Recklessly Endangering Safety, Physical Abuse of a Child, Battery, Disorderly Conduct, Carry Concealed Weapon

On Friday, 07/05/24, at 1850 hours, a subject out of Milwaukee was taken into custody for Disorderly Conduct While Armed and Carrying a Concealed Weapon.
