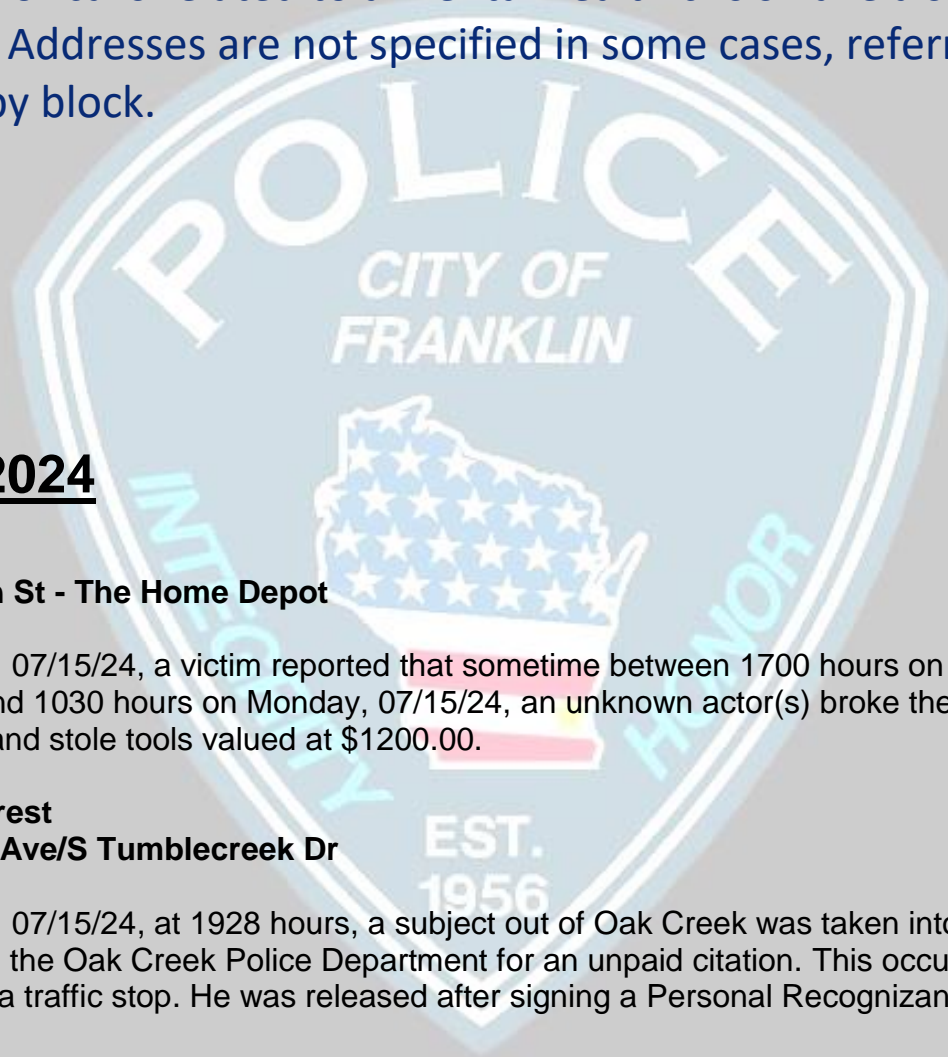

## **07/15/2024**

### **Theft 6489 S 27th St - The Home Depot**

On Monday, 07/15/24, a victim reported that sometime between 1700 hours on Sunday, 07/14/24, and 1030 hours on Monday, 07/15/24, an unknown actor(s) broke the window of his vehicle and stole tools valued at \$1200.00.
