06/10/2024

Possession of Controlled Substance S 27th St/W Ryan Rd

On Monday, 06/10/24, at 0524 hours, a subject was taken into custody for Possession of THC. This occurred pursuant to a traffic stop. He was booked, cited, and released.

Lifesaving measures were attempted by bystanders, FRPD and FFD to no avail and he was later pronounced deceased. The Milwaukee County Medical Examiner's Office will be conducting an investigation. The Wisconsin State Patrol TRU responded to the scene for a reconstruction of the crash. All parties involved in the crash remained on scene and cooperated with the investigation.
