Warrant Arrest 3500 Blk W Ryan Rd

On Monday, 05/27/24, at 0132 hours, a subject out of Milwaukee was taken into custody for having a warrant with the Whitewater Police Department for an unpaid citation. This occurred pursuant to a traffic stop. He was released after signing a Personal Recognizance bond.
