

## 09/09/2024

#### Possession of Controlled Substance/Drug Paraphernalia S 27th St/W Drexel Ave

On Monday, 09/09/24, at 0029 hours, a subject out of Milwaukee was taken into custody for Possession of THC and Drug Paraphernalia. This occurred pursuant to a traffic stop. He was booked, cited, and released.
